





encing financial difficulties. After hearing the individual explain the situation, we were able to provide the Soldier financial assistance.

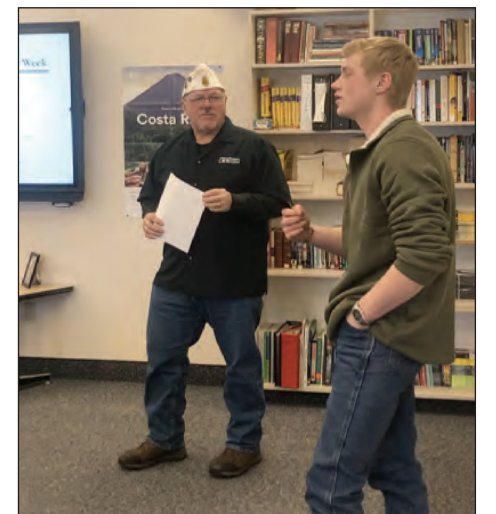
During the past quarter Post 32 Greybull has provided a total of \$2800.00 to veterans in need of financial assistance.

The Unit chairman or President needs to fill out their portion of the information in that box. Remember, Auxiliary Jrs, and young Sons of the American Legion are eligible to enter the contest. Home schooled students, Girl Scouts, Boy Scouts and 4-H members are eligible to submit entries into the essay contest. The deadline to have the top 2 essays in each class is March 31st. Entries can be submitted by ei-

ther email or standard mail with their completed cover sheet but remember that USPS takes 1 to 2 weeks to get across our state.

Does your Unit do something special for all the students that submit essays? Does your Unit give the winners a certificate or prize? Do you put the winners’ pictures in the local paper? Do you put their pictures on the Department Facebook page?

Remember we need to celebrate all these students.

Can you believe that it’s already time to talk about the Year End Reports. Reports are due to me by May 1st. Again, you can email them to me or send them by standard mail. I can’t say it enough, pictures, pictures, pictures, they help tell your Units story.

The Grand Old Flag photo contest offers a creative outlet for showcasing patriotism. All Auxiliary members, Jrs, and young Sons are invited to capture striking images of flags within their communities, whether at a historic courthouse, schools, neighbor’s yards or their own homes. Participants are allowed to submit up to two photos. Make sure to include photographer’s name, Unit, and the location where the photo was taken. The deadline for photo submissions is May 15th, and the entries will be judged at the Department Convention in June. The prize is a 2026 membership renewal.
